#### Insurance Requirements

No permit will be issued without proof of valid insurance. The certificate of liability insurance must be provided a minimum of four (4) weeks prior to the event. This application will not be processed without proof of insurance.

Coverage requirements are:

Commercial General liability insurance with a minimum of \$2.0 million or Commercial General liability insurance with a minimum of \$5.0 million as determined by the Finance Section of the City of Pickering.

Insurance certificate must name The Corporation of the City of Pickering and the Region of Durham as additional insured.

The Certificate must bear the original stamp and signature of the insurance company. The Certificate must be valid throughout the period for which the permit is issued.
