

Covid-19 Waiver and Conditions of Use Pickering City Centre Farmers' Market

I certify that all the information and answers to the questions submitted are true, complete and accurate.

Conditions of Use:

- Maintain a physical distance of 2 metres or 6 feet between yourself and others at all times.
- Wash your hands with soap and water for at least 20 seconds and/or use hand sanitizer before engaging with customers.
- Where applicable, wipe down equipment prior to and after use.
- A face mask must be worn when you have a customer at your booth.
- I will not attend the market if I have any of the following:
 - Fever
 - Cough
 - Difficulty breathing
 - Sore throat/trouble swallowing
 - Runny nose
 - Loss of taste or smell
 - Not feeling well
 - Nausea, vomiting, diarrhea
 - Have you been in close contact with someone who is sick/has confirmed COVID-19 in the past 14 days?
 - Have you returned from travel outside of Canada in the past 14 days?
- The City of Pickering will abide by all provincially or regional restrictions in order to keep vendors, City staff and residents safe.
- Customer capacity and flow will be managed by City of Pickering staff.
- Vendor prohibited to sub-let, or rent their sales space.
- Vendor confirms that the items they are selling at the market have been either made, baked or grown by their company. Market vendors are responsible for indicating all products that they intend to sell at the market on the application form.
- Vendor must be on-site and set-up prior to the market opening and must remain on site the entire duration of the operating hours (9:00 am – 2:00 pm)
- Provide proof of valid insurance for no less than \$2 million naming the City of Pickering as coinsured.
- Provide proof of valid auto liability coverage insurance for no less than \$2 million.
- The City will not be held liable for any loss due to theft, water damage, fire or any other damage incurred to the vendor's products or belongings
- No refunds or partial refunds will be issued for days cancelled due to inclement weather.

I confirm having read and understood the **COVID-19 Waiver and Conditions of Use**, and I agree to them.

I acknowledge that I am responsible for compliance with the **COVID-19 Waiver and Conditions of Use** and hereby indemnify and saves harmless the City of Pickering from and against any and all losses, claims, actions, damages, liability and expenses, including, without limiting the generality of the foregoing, all claims for personal injury, illness or death, including any claims arising from the COVID-19 virus, arising from my failure to comply with the **COVID-19 Waiver and Conditions of Use** or from any act or omission by me arising from or in connection with my participation at the Pickering City Centre Farmers' Market.

I waive any and all claims against, releases from liability and agree not to sue the City of Pickering, its members, officers, employees, agents and representatives, for any personal injury, illness, death or any other loss sustained by me arising out of, or in connection with my participation in City of Pickering's Pickering City Centre Farmers' Market activities, programs, and facility use, including any loss arising from the COVID-19 virus.
