## **Job Summary**

The City of Pickering is seeking a dedicated and motivated individual to join our team in the role of Kindergym Instructor.

The successful incumbent is responsible for overseeing the development, implementation and operation of City of Pickering Kindergym programs as advertised in the City brochure, and to ensure the high quality and safe operation of all Kindergym programs

## **Primary Responsibilities**

- Plans, develops, implements and coordinates, in consultation with the Coordinator, the City of Pickering Kindergym programs.
- Performs all necessary administration for the Kindergym programs such as attendance sheets, accident/incident reports, statistics etc.
- Ensures staff adhere to Corporate and Department policies and procedures.
- Initiates requests for cash advances and cheque requisitions for purchasing required supplies for the Kindergym programs.
- Attends regularly scheduled Program Instructor staff meetings as scheduled by the Coordinator, Recreation Programs.

Additional secondary responsibilities may apply and will be outlined in the Job Description, which will be provided to candidates selected for an interview.

#### **Education and Experience**

- Successful completion of secondary school education or any acceptable combination of education, training and related work experience.
- Gymnastics Coaching Level 1 qualification.

- Proven knowledge, skills and experience in program development and instructing children 6 months to 8 years of age in gymnastics or Kindergym programs. Knowledge and skills in working with children with special needs would be an asset.

- Must be medically and physically fit to perform the duties of the position.
- Must hold current Standard First Aid, and Basic Rescuer CPR-C and Auto External Defibrillator (AED) certificates
- Ability to perform all duties with minimum supervision.

- Demonstrates a commitment and adherence to all aspects of occupational health and safety (legislation, the Corporation's policies and procedures) applicable to the position.
- Must be prepared to undergo a Vulnerable Sector Screening as a condition of employment.
