The City of Pickering is seeking enthusiastic and knowledgeable individuals to join our Public Art Jury. This is a unique opportunity to contribute to the selection of thought-provoking and inspiring public artworks that will enhance our community's identity and enrich public spaces for years to come.

By participating in this important initiative, you'll collaborate with fellow art advocates and experts to ensure the city's public art program reflects the diverse voices, stories, and creative talents of our community. If you're ready to make a meaningful impact and celebrate the power of art, we want to hear from you!

Up to five (5) Public Art Jury Members will be selected for the 2026 term.



About

As a Public Art Jury Member, you will:

- Evaluate and recommend artist proposals for public art commissions in accordance with the City's Public Art Policy (CUL130).
- Contribute to the selection, acquisition, and review of public artworks for the City of Pickering.
- Collaborate with a diverse group of professionals, residents, and stakeholders to ensure the highest standards of equity, transparency, and creativity in the selection process.

Commitment and Compensation

- Term: One year.
- Compensation: Each Public Art Jury member will be paid a flat rate of \$1,480.00 inclusive of HST.* for the year.
- Projects: A Public Art Jury member may review up to six (6) public art projects during the term.

Note, not all five (5) Jury members may be involved for the same project at once. Approved Public Art Jury members will be invited to sit on a project based on their qualifications and availability.

Eligibility and Qualifications

We are seeking individuals with:

- Experience or interest in public art, design, or cultural programming.
- Insights into Pickering's social and cultural landscape.
- Professional expertise (e.g., artists, curators, architects, community organizers) or lived experience that can enrich the evaluation process.

Application Process

To apply, please submit:

- A letter of interest detailing your experience and motivation for joining the Public Art Jury.
- A professional CV highlighting relevant expertise.
